Limited Lifetime Warranty for Tubular Skylights

WARRANTY COVERAGE:

Subject to the conditions, exclusions, and limitations stated herein, Our USA Manufacturer warrants that its tubular skylights products (Product) are free from defects in material and workmanship which will make the Products unfit for their normal and recommended use. This warranty applies only to the person who purchases the product for installation purposes (Customer).

THE DURATION OF THIS WARRANTY BEGINS ON THE DATE OF PURCHASE BY THE CUSTOMER AND EXTENDS FOR THE LIFETIME OF THE PRODUCT AND ODL ACCESSORY PRODUCTS SOLD BY ODL TO THE ORIGINAL PURCHASER OF THE TUBE KIT.

EXCLUSIONS FROM COVERAGE:

This warranty does not cover:

1. Defects or damages arising out of shipment by common carriers, private transportation or other means of transportation.
2. Defects or damages arising out of improper handling or cleaning, defective or improper installation (including installation not in accordance with ODL's installation instructions) defective or improper glazing (including glazing not in accordance with ODL's glazing instructions), accident, act of God, intentional human act, misuse or abuse, or any other circumstances beyond the control of ODL.
3. Products installed in or submitted to high heat, high moisture, high vibration, or extreme temperature changes.
4. Products subjected to stress resulting from (i) localized application of heat, (ii) movement of building and/or building components, or (iii) expansion or contraction of framing members.
5. Products used outside the continental United States.
6. Replacement products beyond the balance of the remaining warranty period applicable to the original Product or accessory which is replaced.

7. Labor, shipping or other charges incurred or claimed by the Customer.

8. Accessories, for other installation materials manufactured or sold by persons other than ODL.

WARRANTY CLAIM PROCEDURES:

If within the applicable warranty period the Customer discovers a defect in the Product or an accessory which is covered by this warranty, the Customer must follow this procedure:

1. The Customer must promptly call or present a written claim to the Customer Service Manager.
2. The Customer must use reasonable diligence to include in the written claim all of the following:
 - a. Adequate description of defect(s).
 - b. Identification of Product (size, design, type and model number).
 - c. Date of the Customer's purchase, place of purchase, and the date of delivery to the Customer.
3. The Customer, at ODL's option, must permit ODL or its representative to inspect the Product.

REMEDIES:

- a. After receiving a valid claim, we will, at its option, provide a replacement Product (or part, as appropriate) of like kind and design.
- b. The manufacturer's liability under this warranty is limited to the and ODL will not be responsible in any even for labor, removal of original product, installation, and expenses, or other charges claimed or incurred by Customer.

Policies

FREIGHT

Most standard orders for our manufacturer skylights will ship prepaid freight to any point within the continental United States. Please call to inquire about special order shipping requirements and/or charges. All weights contained herein are approximate.

For UPS-type orders, dimensional weights may apply rather than actual unit weights. All carriers have their own policies regarding weights and other variables.

ORDERING

We prefers that orders be submitted in writing or via a email. This is to ensure accuracy, completeness of the products produced, and will help reduce delays and errors.

ALL PRICES ARE ON A "PER UNIT" LIST PRICE BASIS.

Changes in orders, IF APPROVED, may result in rescheduling of production or shipping at the discretion of BTS.

LEAD TIME

BTS offers standard products with a 10-15 working day lead-time. These lead-times are based on when the units will be shipped from the manufacturer.

RETURNS

Prior written approval must be obtained before merchandise is returned.
Products in a customer's possession for more than 30 days, special orders, damaged, and/or overstocked items are not subject to returns.

Only product suitable for reshipment and resale will be credited with 75% of the original purchase price. Units must be returned to BTS, Ilc freight prepaid.

PRICING

All prices contained within this list are SUGGESTED LIST PRICES unless otherwise noted.

All prices are subject to change without notice and at the discretion of BTS, Ilc.

The purchaser shall be liable for all sales, Use, Federal, State, County, City, and Excise taxes not included in the total invoice price.

CLAIMS

The Consignee is responsible for fi freight claims with the carrier for loss or breakage while in transit, including, but not limited to, concealed damage.

BTS, LLC DAMAGED SHIPMENT POLICY

BTS, LLC is requiring the following steps prior to accepting the shipment by signing the delivery receipt:

- Properly inspect the shipment for damage.
- Check the condition of the packaging.
- Count the shipping units and verify with the delivery receipt count.

If any of these conditions exist make a notation on the delivery receipt explaining the specific condition of the shipment before signing and accepting or refusing the shipment.

For "Prepaid & Add" or "Prepaid" shipments, if damage has been noted, please contact your BTS, IlcL customer service representative. For "Collect" shipments, if damage has been noted, please contact the carrier immediately. **The customer must handle resolution of the claim directly with the carrier. This also applies if the collect shipment is refused.**

TERMS

Terms, with prior approved credit, are net 30 days. Invoices that are not paid within 30 days are subject to a service charge of 1½% per month (18% per year).

CREDIT

Shipments will not be made to an account with outstanding Accounts Receivable in excess of 45 days without prior BTS, Ilc. approval.

Approval of credit and the setting of monthly credit terms are strictly left to the sole discretion of BTS, Ilc.

A credit application will be forwarded to new customer prospects upon request. Those who apply for credit with BTS, Ilc will be advised of their credit standing and credit limits once the application is processed.

All our customer's information supplied to BTS, LLC will be kept strictly confident subject to, and in accordance with, state and federal requirements.
